GUIDELINES FOR DERMATOPATHOLOGY ON-CALL SERVICE, RUSH CASES, SPECIMEN PICK-UP, AND REPORTING

1. Please direct any questions about the service to Greg Sturtz, Supervisor (919-843-2482).

All RUSH Dermatopathology cases will be processed in the dermpath lab at 2161 Genome Science Building. RUSH cases should be delivered to laboratory personnel in the lab who will ensure processing for next business day a.m. interpretation. If prior to 6:00 p.m., check in the lab (room 2161); if no one is there, then the specimen should be placed in the green drop box at the loading dock of Genome Science Building and **raise the red flag**. The specimens placed in the drop box will be processed for the next business day afternoon interpretation.

Effective 2/8/13, there is no longer RUSH skin biopsy interpretation over the weekend or on holidays. The rush skin biopsies will be interpreted by late in the morning the next business day.

Out of hours cases may be delivered to Southern Village and placed in the black 3-drawer box in the residents' write-up room, or be delivered directly to Genome Science Building and placed in the green specimen drop box described above. If utilizing the drop box, please remember to **raise the red flag** to alert staff that there is a specimen(s) inside.

Specimens from outlying clinics (e.g., Southern Village and Piedmont Health) have three options for delivery to the Dermatopathology Laboratory:

- a. Hand delivery to Dermatopathology staff during normal working
- b. After hours, place in the green drop box in Genome Science Building and raise the red flag.
- c. Delivery to the Southern Village and placed in three-drawer box in the resident's write-up room.
- 2. Reports for Piedmont Health cases are available for viewing in Epic.
- 3. The Immunofluorescence Laboratory is now located in 2358 Genome Science Building. All Immunofluorescence specimens should be placed in the Southern Village refrigerator in the designated location along with an appropriately completed Requisition. Immunofluorescence cases will be picked up at the same scheduled times as Dermatopathology cases (~10:30 a.m., 3:00 p.m., and 6:30 p.m. Monday through Friday). Most Direct Immunofluorescence biopsies should be placed in Michel's transport media. On the rare instance that a specimen on saline moistened gauze is desired IT IS IMPERATIVE THAT THESE SPECIMEN BE EMBEDDED WITHIN TWO HOURS OF BIOPSY. CALL DONNA
