#### **Research Statement**

At the core of my research is medical education and point of care ultrasound. From my first exposures to academic emergency medicine, I was drawn to medical education. My earliest research involved exercise physiology and research with below knee amputee athletes at Adelphi University. As I transitioned into medicine, I began partaking in research evaluating student wellness while I worked as a graduate assistant in the Adelphi University Wellness Center.

During my residency, I was fortunate enough to have been given the opportunity to participate in the Clinical Honors course in medical education. During this course, I learned the intricacies of research in medical education from field experts. I was able to conduct a small-scale research project on resident feedback. In addition, I explored my interests in wilderness and sports science with conducting research on the kidney function assessment in ultra marathoners. I worked internationally with one of the world's most renowned mountain emergency medicine groups based out of Bolzano, Italy to conduct educational research on the utility of an avalanche checklist on knowledge acquisition of first responders. While at Stanford, I also developed a passion for point of care ultrasound. This led to my first project within ultrasound, which evaluated the internal jugular vein in comparison to the inferior vena cava to determine a patients volume status.

Since joining the Department of Emergency Medicine at UNC, I have been able to further expand upon my interests of medical education and ultrasound. This past year was quite successful as I was able to create and implement a point of care ultrasound fellowship. As a pillar of the ultrasound fellowship, I aspire to cultivate a culture of high quality research with a focus on ultrasound and medical education as well as optimizing patient care. Studies underway include the utilization of nerve blocks for pain control in patients with femoral fractures and lower extremity injuries, as well as research being conducted on the success of a novel approach to ultrasound education curriculum for emergency residents.

My teaching career began long before I started a journey in medicine. From the time I taught children from underrepresented communities in New York City with the City Parks Foundation, I knew that teaching was at my core. I continued along this path to teach wellness and activeness while I pursued a bachelors in exercise science. I grew up watching my older brother, a "phys-ed" teacher in the inner city of the Bronx, and his impact on his students to better their lives and give them unique opportunities they may have never had. As I continued to learn, I knew I wanted to be able to provide health care and educate patients and students who faced inequities in obtaining health care.

Since my early exposures to academic medicine, it has been a goal of mine to become a leader in medical education. My passion for medical education was initially cultivated when I was fortunate enough to obtain an Honors Certificate in Medical Education from the Clinical Teaching Scholars Program through the Stanford School of Medicine. From the experience I gained through that program, I was selected to be the Resident Director of Undergraduate Medical Education. This provided me invaluable insights into the intricacies of medical education as I participated in curricular development and medical student assessment and evaluation. Specifically, I helped develop and implement a longitudinal ultrasound curriculum. Upon completion of my term I was awarded the "Academic Achievement Award" as well as "Outstanding Achievement in Ultrasound Certificate" from Stanford.

Currently, I serve as Core Faculty for the UNC Emergency Medicine Residency. During my time at UNC, I have led the point-of-care ultrasound elective in the School of Medicine with Dr. Gilchrest and have facilitated lectures/small group ultrasound learning on a monthly basis. I have also directed the transition to residency ultrasound course for medical students matching into emergency medicine and been involved in the UNC SOM LCME accreditation committee. Additionally, I served on the longitudinal ultrasound curriculum implementation group. In recognition for my dedication to mentoring learners, I have received the Socrates Award for outstanding didactic and clinical teaching in EM, the Most Valuable Attending Award for continued outstanding teaching in EM and the Junior Faculty Award from the Academy of Educators. Most recently, I have been fortunate enough to be selected as the Point of Care

Ultrasound Fellowship Director for the Department of Emergency Medicine. In this position, I have been able to obtain national accreditation for our ultrasound program. Ultimately, my goals are to make sure I am in line with the academic mission set forth by our Department as well as the University of North Carolina School of Medicine.

From my experience as an Italian baseball player in my former life, my philosophy of teaching is grounded in coaching. In that role, I strive to create a positive, inclusive learning environment for students and trainees in an effort to foster a passion for continuous, life-long learning. I particularly love to explore the latest educational trends and best practices, and I pride myself on staying up-to-date on the latest literature in medical education. I believe my background and experience in medical education will continue to add value to the medical school and I am thrilled at the opportunity to continue to promote the University of North Carolina's academic mission.
