State of NC Guidance – 5/20 update

- Phase Two continues May 22 June 6
- Measuring progress
 - Sustained leveling or decreased trajectory in COVID-like illness surveillance over 14 days
 - Sustained leveling or decreased trajectory of lab-confirmed cases over 14 days $\widehat{}$
 - Sustained leveling or decreased trajectory of tests returning positive over 14 days
 - Sustained leveling or decreased trajectory in hospitalizations over 14 days



Guidance from OVCR for Laboratory Research

- 50% occupancy
- Physical distancing
- Safety practices, including PPE and cleaning
- Reduce number of users in DCM facilities
- Cores must focus on cleaning equipment, surfaces before and after use
- Re-arrange equipment to ensure physical distancing
- Symptoms monitoring each employee must perform a daily health check for Covid-related symptoms before coming to work



OVCR Guidance – effective 6/1/20

- Critical activities no longer need approval
- CMDE designation no longer required
- Researchers who can work remotely should continue to do so
- Departments will get approval from research deans for rampup plans
- GMB 5th floor labs should wait to hear from the chair for final approval of ramp-up timing



Art Competition Reminder

- The Department of Genetics has opened a competition to select an art piece to be located in the newly renovated Emeritus Conference Room (GMB 5094). The format is flexible but the piece should fit in the proposed space. Painting, sculpture, photography, collage, mixed media and other visual arts are welcome. The department seeks a highly original piece and the subject matter has no restrictions, but some connection (formal or subjective) to the mission of the department or its members is welcome. Pieces that are contrary to the values and strategic framework of the UNC School of Medicine (research, education, faculty, diversity-equity-inclusion, service and administration) will be disqualified.
- **ARTIST.** The artist(s) should have a connection to the department. Direct or indirect connections are acceptable (please ask if you qualify). Art pieces with team authorship that includes one or more members of the department will also qualify.
- **DIMENSIONS.** Maximum dimensions for the piece are: 8' tall, 30" wide (including frame if needed) and 14" deep. Size will not impact eligibility for the prize.
- **PRIZE.** A single prize of \$600.00 will be awarded to the winner. The stipulation for the winning piece is that it will be donated to the department for display in the conference room.
- **SUBMISSION PROCESS.** Artists should submit up to three high-quality photographs of the art (suitable for judging) and include the name of the artist, a short paragraph describing the piece, and the dimensions. Please send submissions by email to Cathy Cornett at:

- **REVIEW AND SELECTION.** Photographs of the submitted pieces will be posted online for review for a period of two weeks. The winner will be selected by popular vote of qualified members of the department using a survey tool that will be provided by email.
