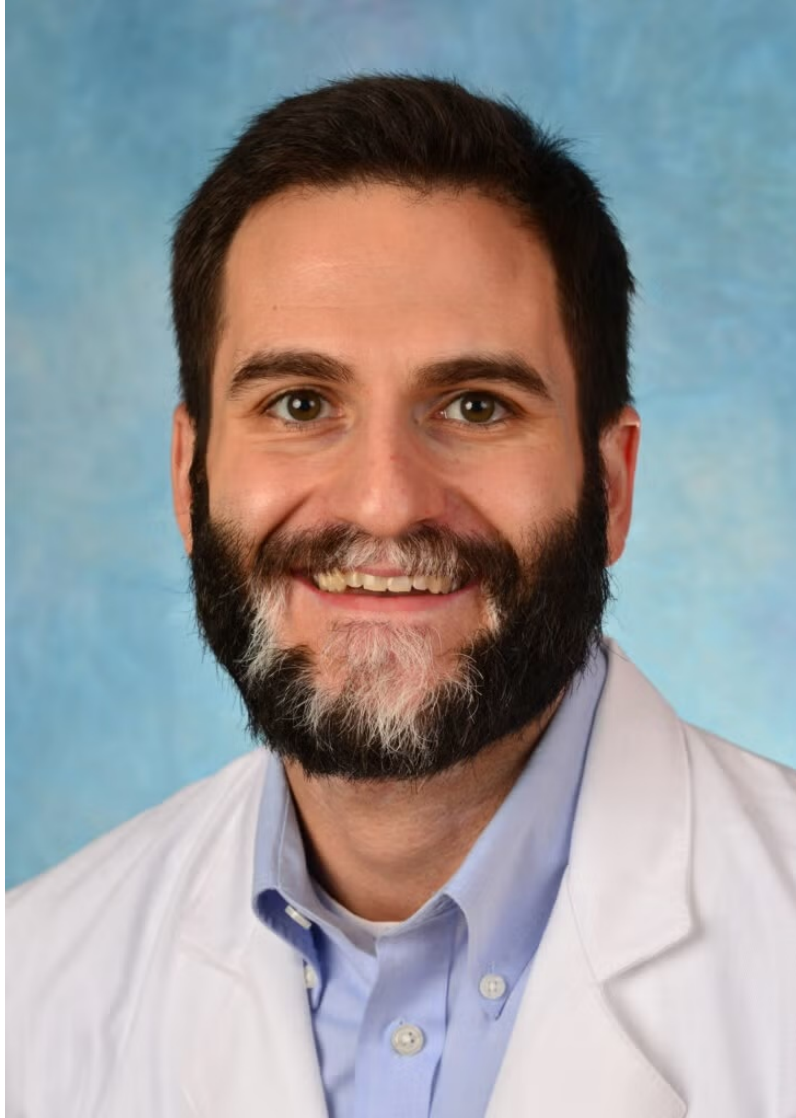

### **The Heusner Pupil Award**

The Heusner Pupil Award was established in 1964 by the family and colleagues of Dr. A. Price Heusner, who served as Professor of Surgery at North Carolina Memorial Hospital (1952-1956) and as Professor of Anatomy at the School of Medicine (1956-1963). It is provided to a member of the fourth-year class who best exemplifies qualities displayed by Dr. Heusner during his career as a physician, teacher, husband, and father: a capacity to grasp the principles of science, to demonstrate concern for the moral welfare of human beings, to heal the sick, to comfort the troubled, and to be humble. The recipient is honored for meritorious character and potential, and is selected by a committee that includes members of the medical school faculty.
