Laura C. Hanson, MD, MPH: Reflective Statement

Clinical Expertise and Leadership

I am a tenured Professor in the Division of Geriatric Medicine, Department of Medicine at the University of North Carolina – Chapel Hill. After receiving my medical degree from Harvard Medical School and training in Internal Medicine at the Brigham & Women's Hospital in Boston, I completed residency and Geriatric Medicine fellowship at the University of North Carolina. Following research training in the Robert Wood Johnson Clinical Scholars Program, I joined the UNC faculty in 1992. In 1997 I was honored as a Soros Project on Death in America Scholar, and through this national leadership training program developed expertise in the emerging field of Palliative Medicine. Board-certified in Internal Medicine, Geriatric Medicine, and Hospice and Palliative Medicine, I seek to provide compassionate and evidence-based clinical care for frail and medically complex older patients, and for adults of all ages facing serious illness.

Beginning in 2001 Dr. Stephen Bernard (Division of Hematology & Oncology) and I co-founded and led the UNC Palliative Care Program. In 2018, after comprehensive strategic planning, the UNC Department of Medicine Palliative Care and Hospice Program was formed and I was selected as its Medical Director. The Program reports to the Vice Chair for Clinical Services in the Department of Medicine, and operates with funding from UNC Hospitals. This interdisciplinary Program connects many sectors of UNC Healthcare – faculty are appointed in the Departments of Medicine, Psychiatry, and Family Medicine, and they work with an interdisciplinary team employed by UNC Hospitals. As Medical Director, I engage with multiple Department and Division Chairs in the School of Medicine, and administrative leadership from UNC Hospitals and Health System.

Clinical palliative care services reach 5.8% of admitted adult patients at the UNC Medical Center, and in FY20 had approximately 6000 patient encounters across inpatient and outpatient adult and pediatric populations. Faculty physicians provide all medical services for UNC Hospice, including coverage for its 10-bed Inpatient Hospice Unit. Palliative care has played a central role in the response to COVID-19 – expanded MICU consultations, outreach and consultation to nursing home outbreak sites, and rapid targeted education in Advance Care Planning for colleagues in our Emergency Department.

Our Palliative Care Program is academically engaged in order to realize shared goals of the School of Medicine, UNC Hospitals and Health System. UNC has an ACGME certified Hospice & Palliative Medicine fellowship. Faculty provide extensive education to residents and students, and serve as principal or co-investigators in palliative care clinical research.

Teaching Activity

While I contribute routinely to clinical teaching in Geriatrics and in Hospice & Palliative Medicine, my major contributions are in research and career development for fellows and junior faculty. I have 5 current research mentees, and have mentored more than 40 individuals on dissertations or original research projects; 27 continue in academic medicine or public health careers. As faculty to the Geriatric Medicine Fellowship and the Hospice & Palliative Medicine Fellowship, I teach methods of quality improvement and research. This opportunity to mentor new investigators is invigorating and inspiring, and a reflection of UNC's collaborative culture to promote academic inquiry and scholarship.

My teaching activity extends to audiences beyond UNC Medical Center. I have been an invited speaker at the Institute of Medicine, the Aspen Institute, the Veterans Administration, and the National Institute on Aging, as well as invited lectureships and grand rounds at major academic medical centers. In addition, I have sought to contribute to public outreach education. I have created and published results from two public outreach curricula in advance care planning and palliative care -- an award-winning curriculum for nursing home staff, and a case management curriculum for the North Carolina

state Medicaid program. Public outreach education is highly relevant to my current leadership role on the UNC Health System's Advance Care Planning Task Force, designing and implementing systemwide tools and training to promote advance care planning.

Diversity, Equity and Inclusion

I entered the field of medicine from a privileged background – white, supported by family with social, financial and educational attainment, and access to excellent training. Early in that educational pathway, my awareness of privilege began to expand in large part by moving to North Carolina and exposure to the historical underpinnings of this state and region. Further, engagement with the unique resources of the UNC School of Public Health and the UNC SOM Department of Social Medicine enhanced my education in the impact of health disparities and implicit bias in the delivery of healthcare.

At least for myself, I am convinced this work is never finished. Faculty activities to promote diversity, equity and inclusion must be woven into continuous efforts to address structural sources of barrier and bias. Some specific activities include:

- Leading funded research to address health disparities in palliative and supportive care for African-Americans with cancer, working with and learning from Giselle Corbie-Smith who leads the UNC Center for Health Equity Research.
- Serving as a member of the Data Safety Monitoring Board for the REACH Equity Disparities Research Center (Duke, Kimberly Johnson, PI), which houses projects on implicit bias training for Duke provider, and two clinical trials of novel interventions to address health disparities in clinical care of serious illness populations.
- Providing clinical service on the inpatient Palliative Care team at UNC Medical Center which disproportionately serves African American and Latinx populations, in response to their greater exposure to serious illnesses and suffering magnified by barriers to care, and
- Supporting and structuring diversity and implicit bias training for the UNC Palliative Care Program beginning in 2020.

Research and Scholarship

Evidence-based palliative care interventions are critical for the well-being of seriously ill patients, and this research has important implications for the US healthcare system. I lead a productive program of funded research at the intersection of Geriatrics and Hospice and Palliative Medicine, supported by grants from NIA, NINR, CMS and foundation sources. I have over 190 peer-reviewed publications and nationally recognized scientific contributions in four areas: 1) palliative care for late-stage dementia, 2) palliative care for other serious illnesses, 3) measuring quality of palliative care and hospice, and 4) geriatric pharmacoepidemiology.

- First, I have been Principal Investigator for three NIH R01-funded randomized clinical trials, and coinvestigator for others, to test palliative care interventions for people with advanced dementia and their family caregivers. Two clinical trials found evidence for the effective use of decision aid interventions in nursing home care of advanced dementia. One – the Goals of Care trial – was named among "10 high-impact articles published in the geriatrics literature for 2017." I currently lead the NIA-funded ADRD-PC study, the first clinical trial testing specialty palliative care for patients with late-stage dementia. Combining public outreach education and research, I lead two studies of video-based training – one for comfort-focused dementia care for nursing home staff, and one for dementia-specific advance care planning in primary care. Building on this expertise, I now lead the Patient and Caregiver Relevant Outcomes Core for the NIA-funded IMPACT Collaboratory, a major initiative to expand pragmatic clinical trials in dementia care.
- Second, I have led or been a co-Investigator on palliative care clinical trials or quality improvement interventions to enhance palliative and supportive care in serious illness. This research has resulted from effective collaborations with other UNC faculty, including community-based supportive

oncology for African-Americans (Giselle Corbie-Smith, Jo Anne Earp) in Pulmonary Medicine (Shannon Carson, Blair Wendlandt), in Nephrology (Mi-kung Song, Jerry Hladik, Jenny Flythe, Emily Chang), in Supportive Oncology and Psychiatry (Don Rosenstein, Leeza Park, Antonia Bennett, Matt Milowsky, Fran Collichio, William Wood), and in Pediatric Pulmonary and Pediatric Palliative Care (Elisabeth Dellon). This line of research has led to development and testing of several novel and pragmatic interventions; these include:

- o community-based supportive oncology for African-Americans with cancer,
- o collaborative oncology palliative care for patients with Stage IV cancer,
- o ICU communication to address chronic critical illness,
- o outpatient palliative care for adults with cystic fibrosis, and
- advance care planning and outpatient palliative care for patients with end-stage renal disease.
- Third, as a leading investigator on the CMS-funded PEACE Project, I have developed clinical quality measures for hospice and palliative care. These quality measures have been endorsed by the National Quality Forum and are applied nationwide in Hospice care. This expertise is further applied in my role as Principal Investigator for the Measurement Core of the Palliative Care Research Cooperative group, the only NIH-funded clinical trials collaborative for the field. My expertise is further deployed in national service to the Academy of Hospice & Palliative Medicine, as Chair the Quality and Research Strategic Coordinating Committee, facilitating AAHPM's leadership of a national quality registry for palliative care.
- Finally, I have been a research collaborator for studies of geriatric pharmacoepidemiology, an important topic in patient safety and quality of care for older patients. Collaborators include faculty across Geriatrics (Josh Niznik), School of Public Health (Til Sturmer, Jennifer Lund), and School of Pharmacy (Carolyn Thorpe).
