RESEARCH STATEMENT

My research is focused on understanding gender-based violence in a time of racial mass incarceration and on building reparative possibilities in scholarship and policy. I apply innovative quantitative and mixed-method strategies to confront the systems of state power and group-based privilege that generate gross health inequities along lines of race, class, gender, and sexual orientation.

One line of my research uses latent variable modeling and mixed-method techniques to examine private forms of violence (particularly intimate partner violence, child maltreatment, and suicide) in US communities that are heavily subjected to the public violence of the state. I apply social-ecological theory, a feminist conceptualization of gendered labor and gendered violence, and critical sociological theories of penalty to consider how the fallout of mass criminalization and punishment is absorbed, and concealed, in the domestic sphere.

Growing out of my research on penalty and gendered violence, my other line of inquiry concerns reparations questions and reparative research methods. This work examines epistemological and material strategies for confronting entrenched white political-economic domination and the

gendered exploitation and violence in which it is embedded. Acknowledging the role of knowledge production itself in sustaining inequity, I am pursuing a reparative methodology for health equity research that engages directly with reparations questions beyond the academy.

My empirical research on reparations revisits the “collateral consequences of mass incarceration” literature, finding ill-gotten benefits of mass incarceration for white Americans. Applying social-ecological theory and an innovative quantitative method, I have also developed rigorous estimates of the total economic harm of mass incarceration in Black communities, arguing that reparations are integral to any effort to decommission our current penal system and the racial power structure it upholds. This work is the subject of my book, *Stolen Wealth, Hidden Power: The Case for Reparations for Mass Incarceration*. My next book project takes a wider geographic and epistemological lens, examining the role of social and public health research in illuminating (or foreclosing) global and transnational reparations questions.

Questions of methodology are of central interest to me. My initial methodological work is published as a series of methods articles and a lead-authored book (*Holding On: Fatherhood and Family During Incarceration and Reentry*). Extending this work, I have recently embarked on a new project with Sara Wakefield reanalyzing multi-reporter, mixed-method datasets to identify patterns in discordant accounts of family life among families separated by incarceration.

In addition, I am engaging the implications of racial criminalization for public health and health equity research under a K99-R00 award from the Eunice Kennedy Shriver National Institute for Child Health and Human Development. The project, “Institutional Contact and Family Violence in an Era of Mass Incarceration,” responds to the fact that, in a time of mass criminalization, vulnerable communities have good reason to orient defensively to institutional inquiry, including academic research. To confront the challenges this historical context poses to research on sensitive and criminalized life experiences, especially violence, I am testing a series of quantitative and mixed-method strategies that could surface a more complete and complex picture of private experiences, while treating the undisclosed as a meaningful object of study in itself.

TEACHING STATEMENT

An ability to think critically about complex systems—including systems of health care, political economy, and knowledge production—is among the richest learning opportunities that social medicine can offer. I aspire to a teaching career that yokes the generative energy of medical teaching and learning to transform each of these complex systems in service of health equity.

My positive experiences with individualized teaching and learning in the British higher education system guide a teaching approach that centers the intensive development of medical students’ own interests, critiques, and visions for innovation. I am especially excited to teach social medicine and health equity to medical students in the Foundation Phase of the Social and Health Systems course sequence.

I am also eager to mentor and collaborate with students interested in the intersection of health and carceral systems and the broader political economy. Mentoring five junior scholars in their first peer-reviewed publications has shown me the potential of closely mentored academic writing for teaching argumentation and for guiding students in building a clear, precise, and humble understanding of where their work might contribute to an evolving body of knowledge. I hope to offer medical students the tools to advance their own evidence-based visions for social and material transformation, in and beyond the practice of medicine.
