### REFLECTIVE STATEMENT

Harold Thurman Whitman once said, "Don't ask yourself what the world needs - ask yourself what makes you come alive, and then go do it. Because what the world needs is people who have come alive."

After reading that statement one day, I took a long look at where my career was and took a step back to re-prioritize. What were the things in life that made me come alive? Delighted with my immediate first response, my family, I reflected on what makes or would make me "come alive" with my career. I decided to write down some key phrases...

- 1. Recognizing the humanity in medical/surgical care
- 2. Pride and protectiveness of your outcomes
- 3. Encouraging and teaching residents to see #1 and #2

What do I mean by these phrases? Let me explain. All too often I hear the complaint that "surgeons are surgeons...You cannot change that." Well, why not? I have the privilege of caring for many patients with spinal cord injuries, Parkinson's disease, multiple sclerosis and other neurological disorders. All too often, the urological effects of these diseases are glossed over in favor of the more visible things (i.e. mobility, tremors, etc...). The impact of the change in their urinary habits and control, however, is usually a major contributor to a decrease in quality of life after injury/diagnosis. Caring for these patients and educating them on why they are having urological issues is something that I love to do. I enjoy working together towards developing treatment plans that work in the context of each patient's short and long term goals. Working at UNC has allowed me to have the resources and multi-disciplinary team to care for these patients in, what I hope is a comprehensive, quality of life driven and compassionate manner. By doing so, I hope to be able to improve outcomes in this most deserving population. In order to be a good physician/surgeon, you have to, in my opinion, be a bit vain. You need to take pride in your care, be it clinical or surgical. My mentor taught me, if the phrase, "I think it will be OK runs through your mind" stop what you are doing immediately and fix it. I have taken this approach to my career. During cases, I will often point out steps to the resident that can have an effect on the outcome. If I'm not happy with how the case is going, we will step back for a moment, talk things over and

then, proceed. Honestly, I tend to be a bit more "hands on" that I am sure the residents would like but I hope they see that as a reflection of my dedication and concern for my patient.

If there is one thing I hope the residents learn from me, it is that last statement. Medical and surgical management can and will be taught very well during the residents time with us at UNC. What you cannot teach, however, but merely can show by example, is how we should "care" for our patients....with dedication, concern and pride. These are traits that I have found are commonplace at UNC...no small accomplishment.

Caring for an underserved, sometimes unrecognized, population of urology patients has become my main focus in my clinical work. It is this that has made me "come alive" at work. I am grateful for the opportunities that UNC continues to provide that allow me to do a job I love every day.

# TEACHING STATEMENT

Education has been one of the most influential cornerstones of my life. As the child of educators (middle school math and science), many of our family dinners focused on the trials that my parents faced as teachers. Many of these trials are those that continue today in medical education. Lack of time, funding, interest and the ever-present trial of engaging the learner in materials they may not be interested in learning. My parents would speak of the student that would perhaps excel in one area but struggle in another (i.e. math) and brainstorm different ways in which they could, 1) engage the learner in the topic, 2) make the topic applicable to their interests and 3) help the learner to understand, not just memorize the lessons. It was these dinner sessions that prompted my interest in education, and although I knew I wanted to pursue medicine rather than primary education, prompted my interest in academic medicine. Throughout my time at UNC, I have sought to improve my teaching abilities through participation in the *Passing the Torch* Clinical Teaching Program as well as the *Teaching Scholars* program under the leadership of Drs. Amy Weil and AnnaMarie Connolly respectively.

I have been involved in a variety of educational opportunities within the UNC involving learners ranging from college students to fellows. Through the Alpha Epsilon Delta (UNC pre-health professional honor society), undergraduate students from UNC spend time with me in the clinical setting to gain exposure to the world of clinical medicine. While some of these students come once, some have spent many months with me allowing for "entry level" teaching of urologic issues. I am actively involved with medical student education both as a lecturer during the foundation phase and as the coordinator for the urology clerkship. In addition to the normal "bedside" teaching of our urology residents, I am also actively involved in educational lectures and also hold an annual urodynamics review session prior to their inservice. In addition to standard lectures for the urology residents, I am also involved in a lecture series for the spinal cord injury unit for the physical medicine and rehabilitation residents and a multi-lecture annual series for the UNC urogynecology fellows.

In 2016, I was given the opportunity to design and implement a urology curriculum for the UNC Physician Assistant program. Having a review book as my guide, I created 8-10 contact hour worth of lectures and cases for the PA students. In

2017, I was nominated to participate in the *Teaching Scholars* program under the tutelage of Dr. AnnaMarie Connolly. As part this program, I sought to implement a new curriculum for the 2018 PA urology lecture series that would allow for more learner engagement and, in turn, result in a better understanding of and performance on their urology portion of the curriculum. Through a redesign that now provided the learner with pre-recorded lectures on the applicable topics, we now were able to spend the contact hours in case based simulations rather than strict didactic lectures. Feedback from the learners and assessors was very positive and this resulted in better performances not only on the test but with the standardized patient scenarios as well.

I hope to not only continue teaching a variety of learners but to continually strive to improve my teaching abilities so that I can engage my learners and make the material "come alive."
